## Half-yearly news bulletin on the activities of the Indian Radio Regulatory Service Officers' Association (IRRSA)- period ending June, 2021

### Cadre Review:

The Executive Body of your Association have given utmost priority to the ongoing cadre review proposal of the IRRS. The members may be aware that the cadre review proposal was forwarded by the department (DoT) to DoP&T in December, 2019 after due approval of the Hon'ble MOC. The proposal was examined by DoP&T and their views/ comments were subsequently vetted by DoE by the end of March, 2020. The proposal was scheduled to be considered by the Cadre Review Committee (CRC, a Committee of Secretaries headed by Cabinet Secretary) on 25th June, 2020. However, the scheduled meeting was postponed indefinitely on the request of DoT. Meanwhile, the matter was regularly pursued by the encadred officers with the DoT Administration.

- The present Executive Body, formed after the election held in December, 2020, met Secretary (T), AS (T) and JS (A) on several occasions during January & February, 2021 with the motive to persuade them to request Cabinet Secretariat to include IRRS Cadre in its immediate next meeting of the CRC.
- Based on the discussion held with DoT Administration in this regard, a letter was also issued to Secretary (T), DoT, in the similar line.
- As advised by DoT Administration, a letter with the draft Response to the Draft CoS Note of the DoP&T has also been made issued to them through WPC Admin.
- As an outcome to the continuous persuasion, the meeting of the CRC to consider the above cadre review proposal was scheduled on 25 February, 2021.
- In the CRC meeting held on 25 February, 2021 the matter was deliberated in an affirmative manner and most of the members were in favour of strengthening the cadre. However, the meeting was inconclusive and further input/ information was sought from DoT.
- Accordingly, the draft input/ information from DoT (as prepared by the Association), was put-up on file from DoT Admin for approval of competent authority. Secretary (T) desired for a presentation on the same which was scheduled on 16 April, 2021; however, it got postponed. Meanwhile, due to 2<sup>nd</sup> wave of the COVID-19, the matter got delayed further. From June, 21 onwards the matter has again been vigorously pursued by your Association and the case is now pending with Secretary (T).

• The issue is being closely monitored and followed-up; your Association is considering to take-up the matter to highest echelon of the Government in case of further unreasonable delay. However, it is expected that the input/ information from DoT will reach DoPT within a reasonable time.

### Central Staffing Scheme:

The members may be aware that Central Staffing Scheme (CSS) is a provision to man posts in the Ministries/ Departments of the Govt. of India at DS/ Director and above levels. It draws officers from the All-India Services cadre officers and participating Group –A organised services. The cardinal purpose of the scheme is the Centre's need for fresh inputs at senior levels in policy planning, formulation of policy and implementation of programmes from diverse sources. Currently, 37 organised Group-A services are currently, the participating services under the Scheme. IRRS cadre is yet to be inducted into the list.

- Earlier, in August, 2017, a letter with the approval of Secretary (T) was issued to DoPT to include the IRRS Cadre into the participating service list under the CSS. However, no response was received.
- Your Association has followed-up the matter with DoPT and it is learnt that a fresh proposal, with detailed justification for inclusion of the IRRS cadre in the CSS list, needs to be moved from the DoT with the approval of Hon'ble MOC.
- Since then, the Executive Body have drafted a 'detailed proposal' in this regard which will be finalised in its next meeting(s). Subsequently, the matter will be taken-up with the DoT Admin for onward administrative action from DoT.

### Diary/ Planner & Logo of the IRRSA:

The Executive Body of your Association is very pleased to inform that the first ever Diary/ Planner of the Association has been published this year (in the month of Dec/ Jan) and were distributed to all the members of the Association posted at different offices.

- Besides, the Diary/ Planner has also been handed over to the Hon'ble MoSC (newly joined) and senior officers of the department including Secretary (T), M(T), M(F), AS, JS (A), JS (T) & officers of other Ministries too. In general, the feedback from the members on this initiative of the Association, is very encouraging.
- Your Association is also pleased to inform that the Executive Body have adopted, through Resolution, a Logo of the Association based on the inputs received from the members of the Association. The same has also been imprinted on the Association Diary/ Planner.

- Besides, the Executive Body met Hon'ble Minister Shri Arjun Ram Meghwal and apprised him the current status of the cadre review proposal of the IRRS.
- The Executive Body have also made a courtesy call to Secretary (T), AS(T), Member (T). member (F) and other senior officers of DoT Administration and that of DoE, DoPT etc after its formation.
